

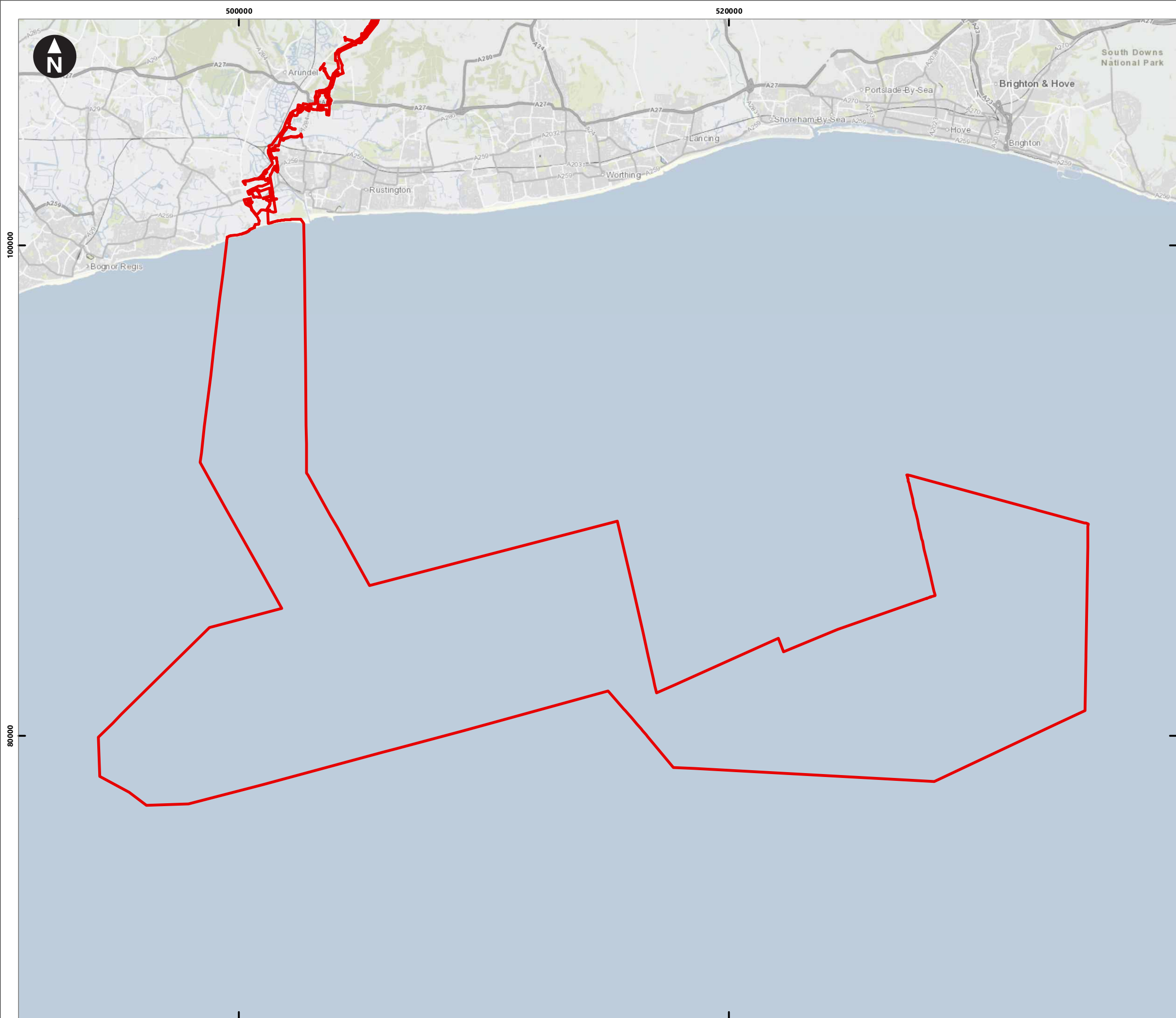

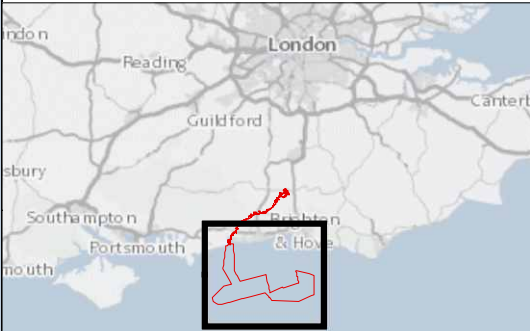
Figure 4.1	Offshore part of the PEIR assessment boundary

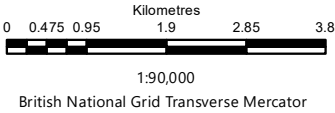
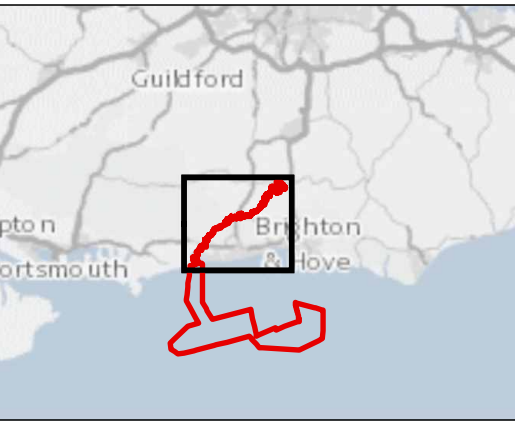

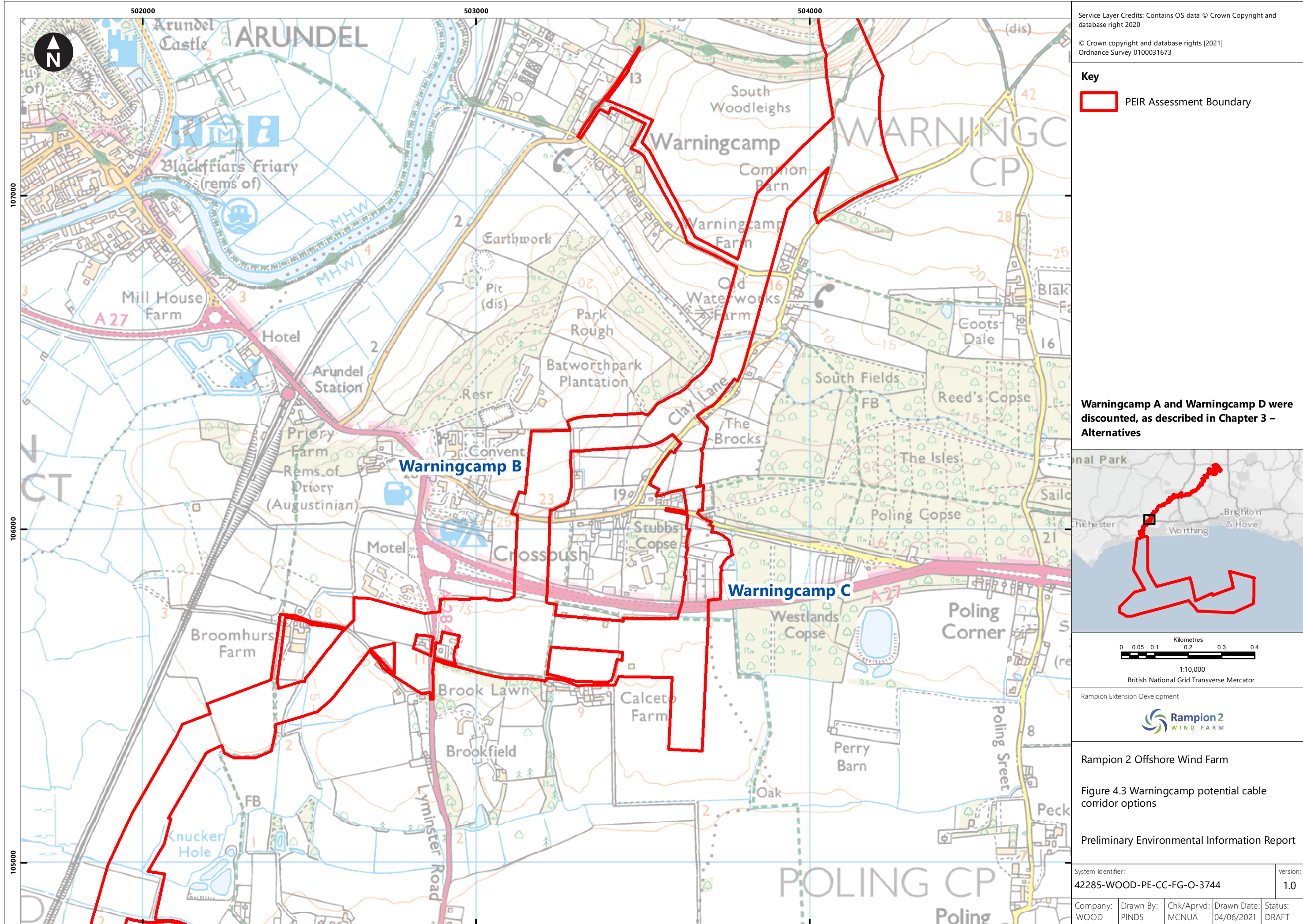
Figure 4.2 Onshore part of the PEIR

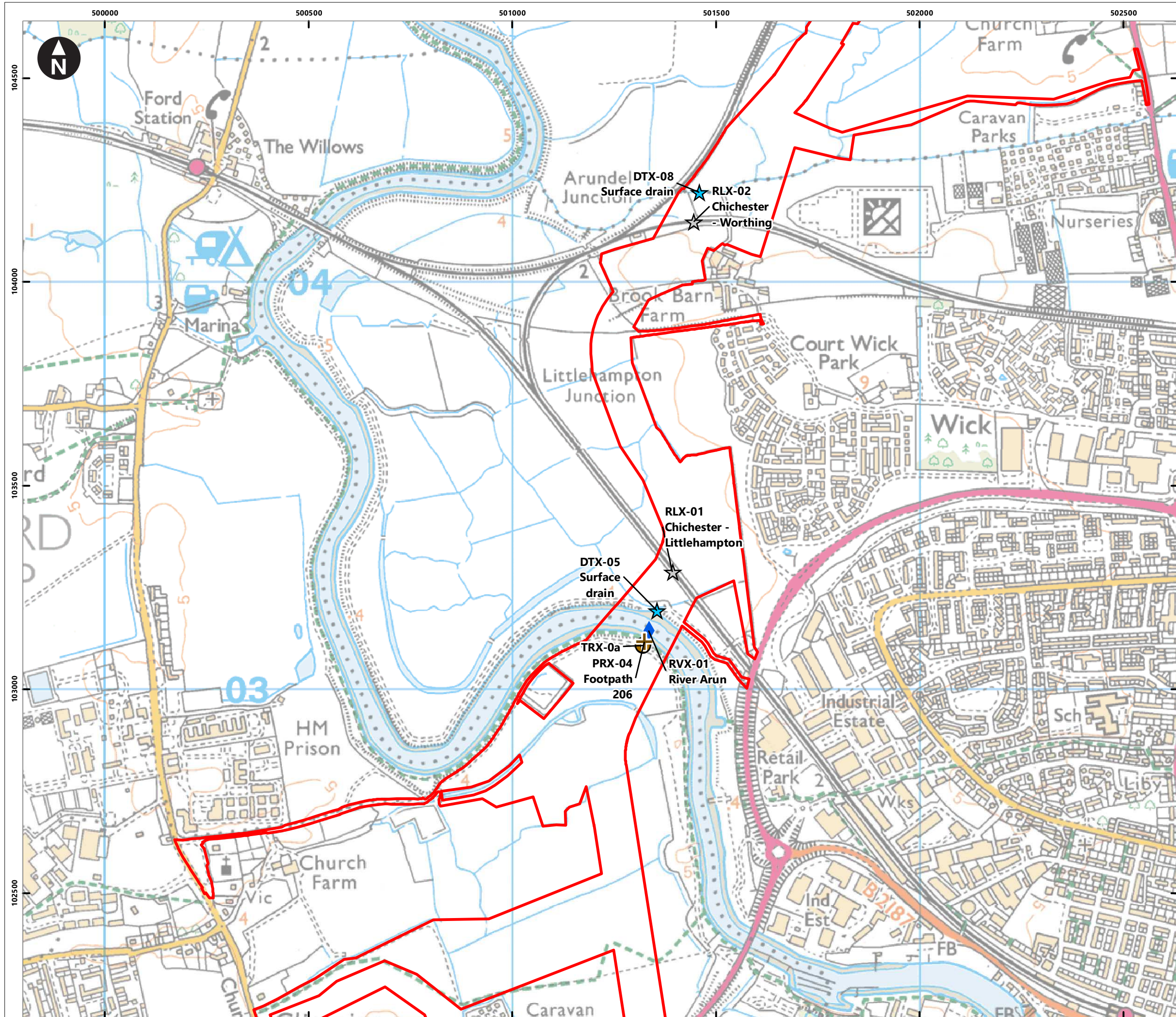

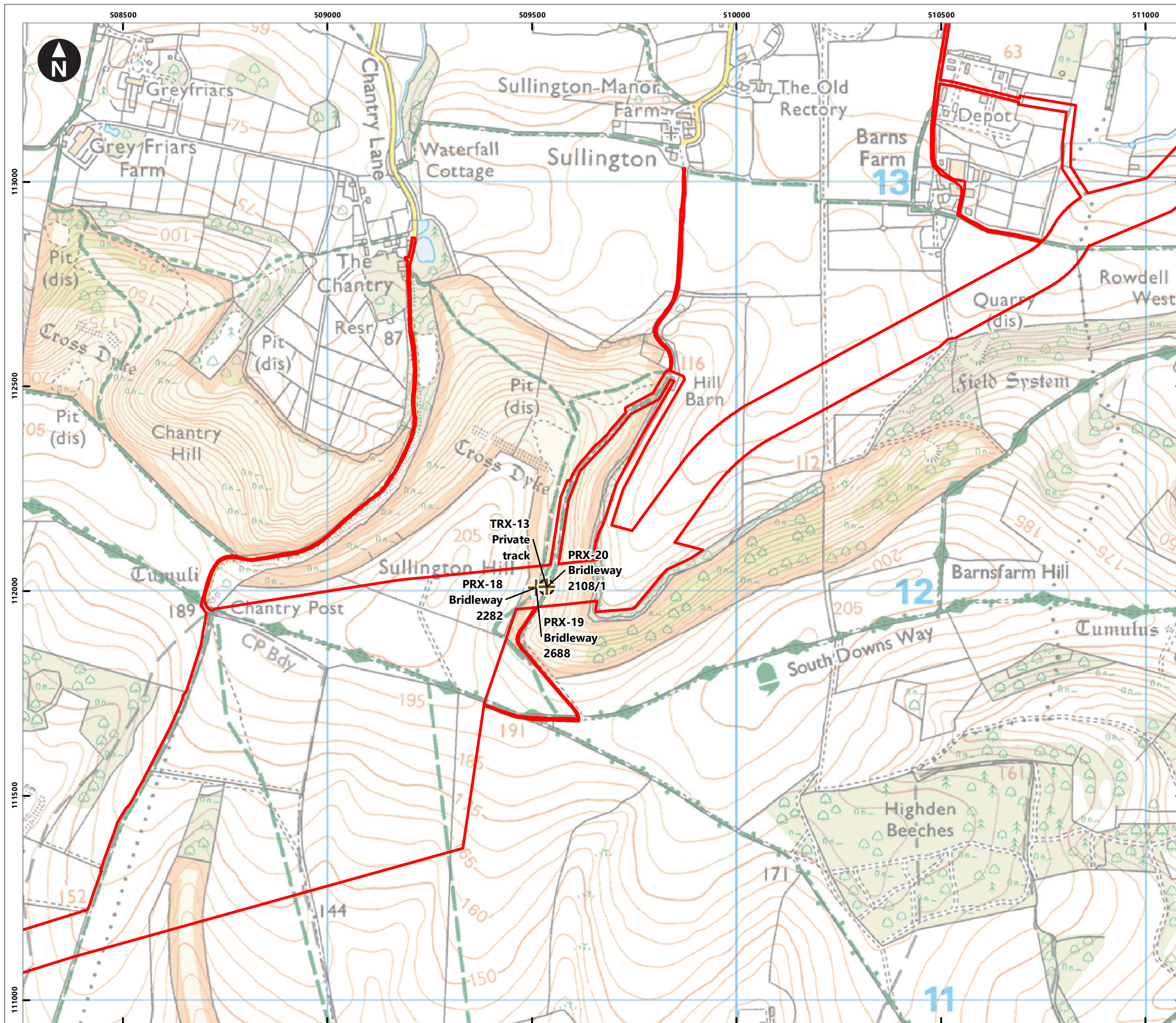
Figure 4.5c Location of likely trenchless crossings

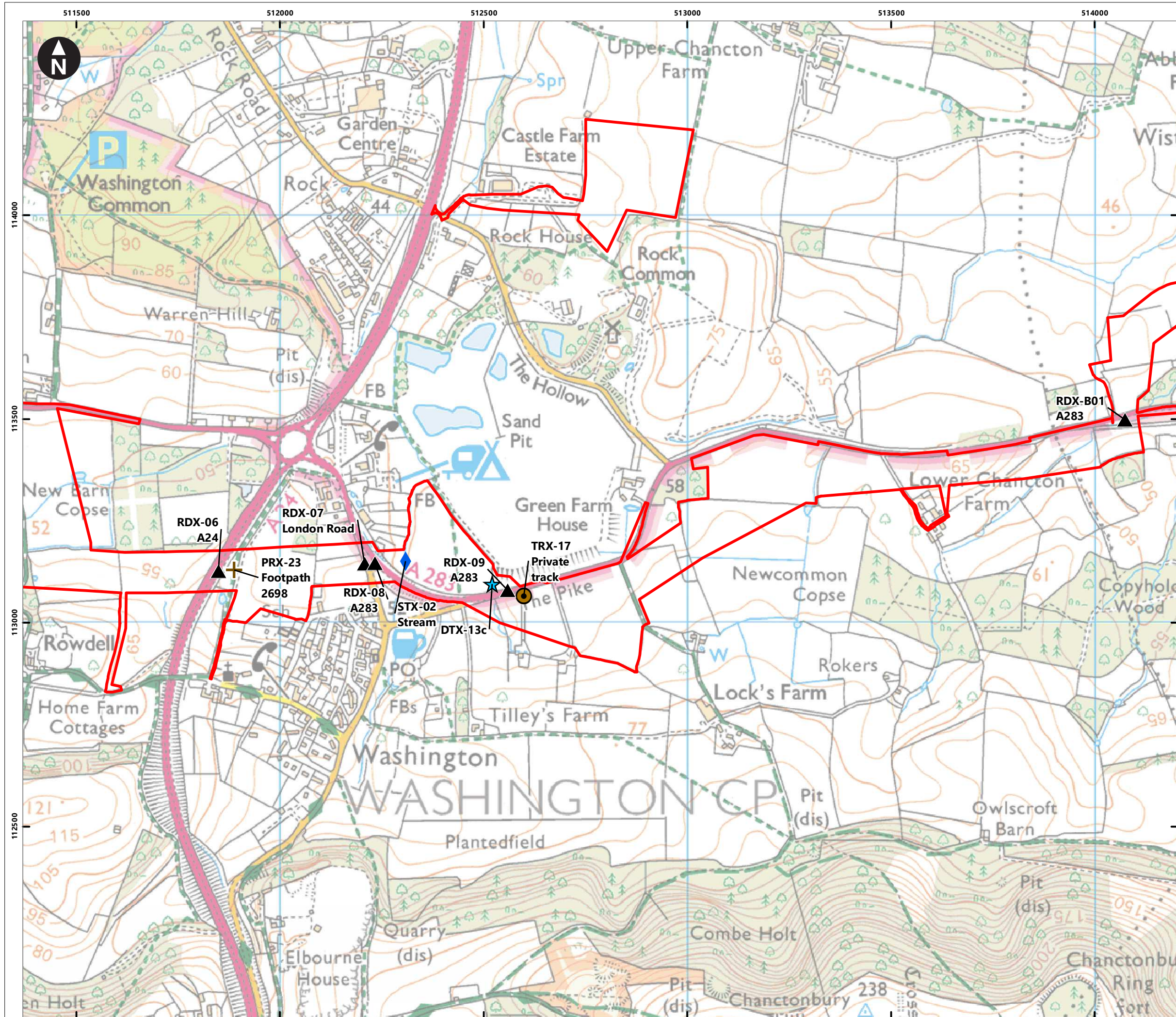

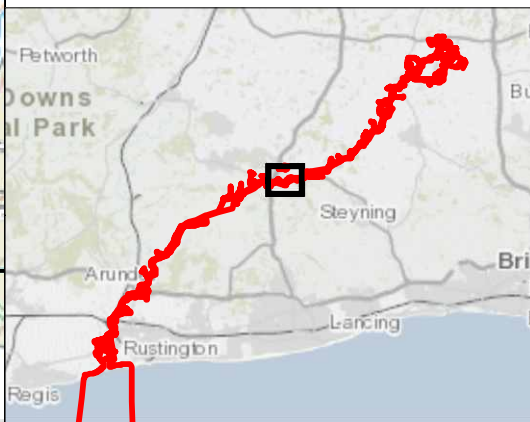

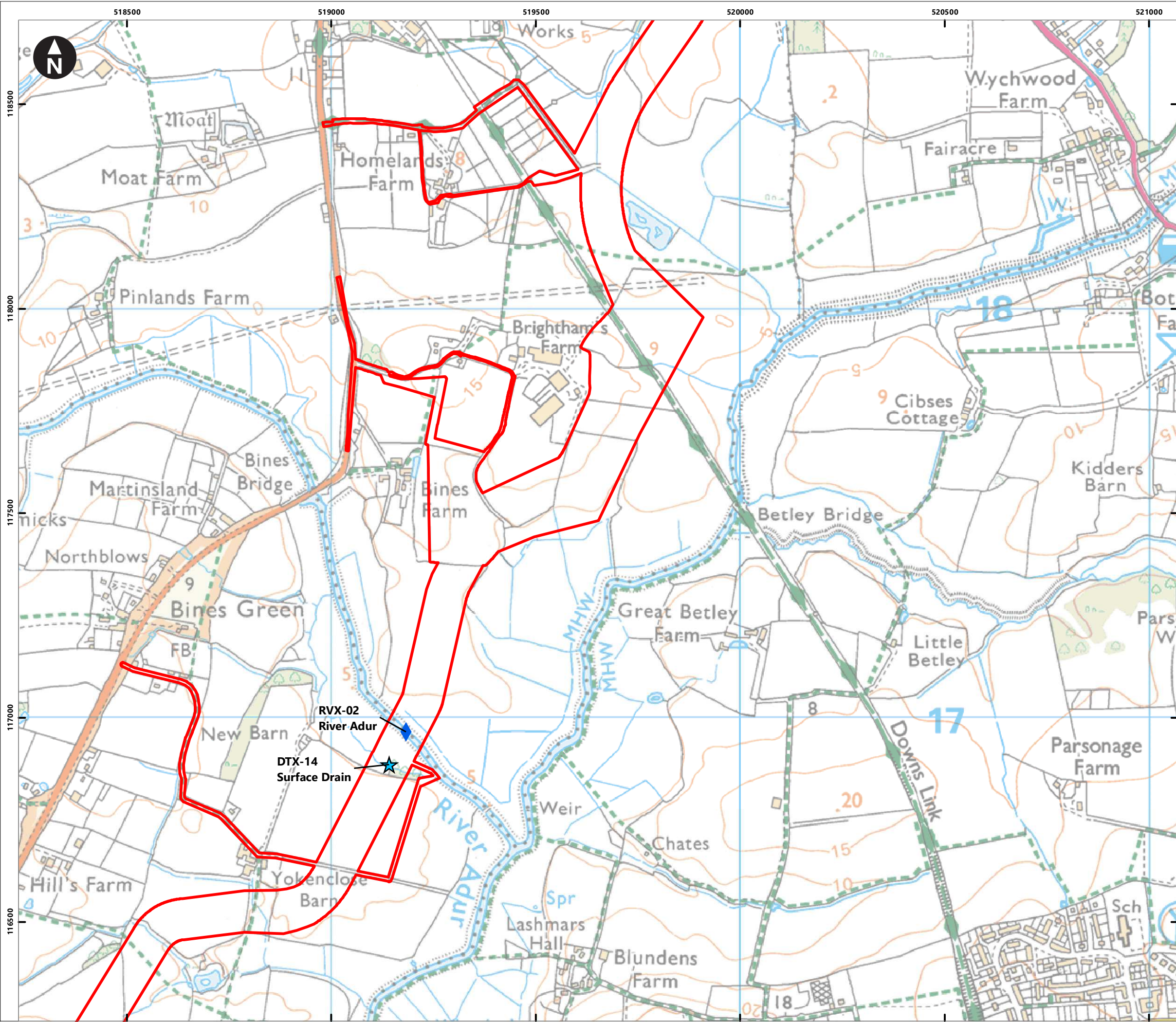
Figure 4.5e Location of likely trenchless crossings

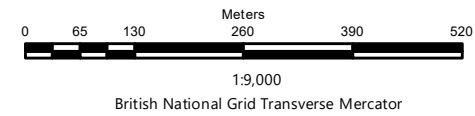

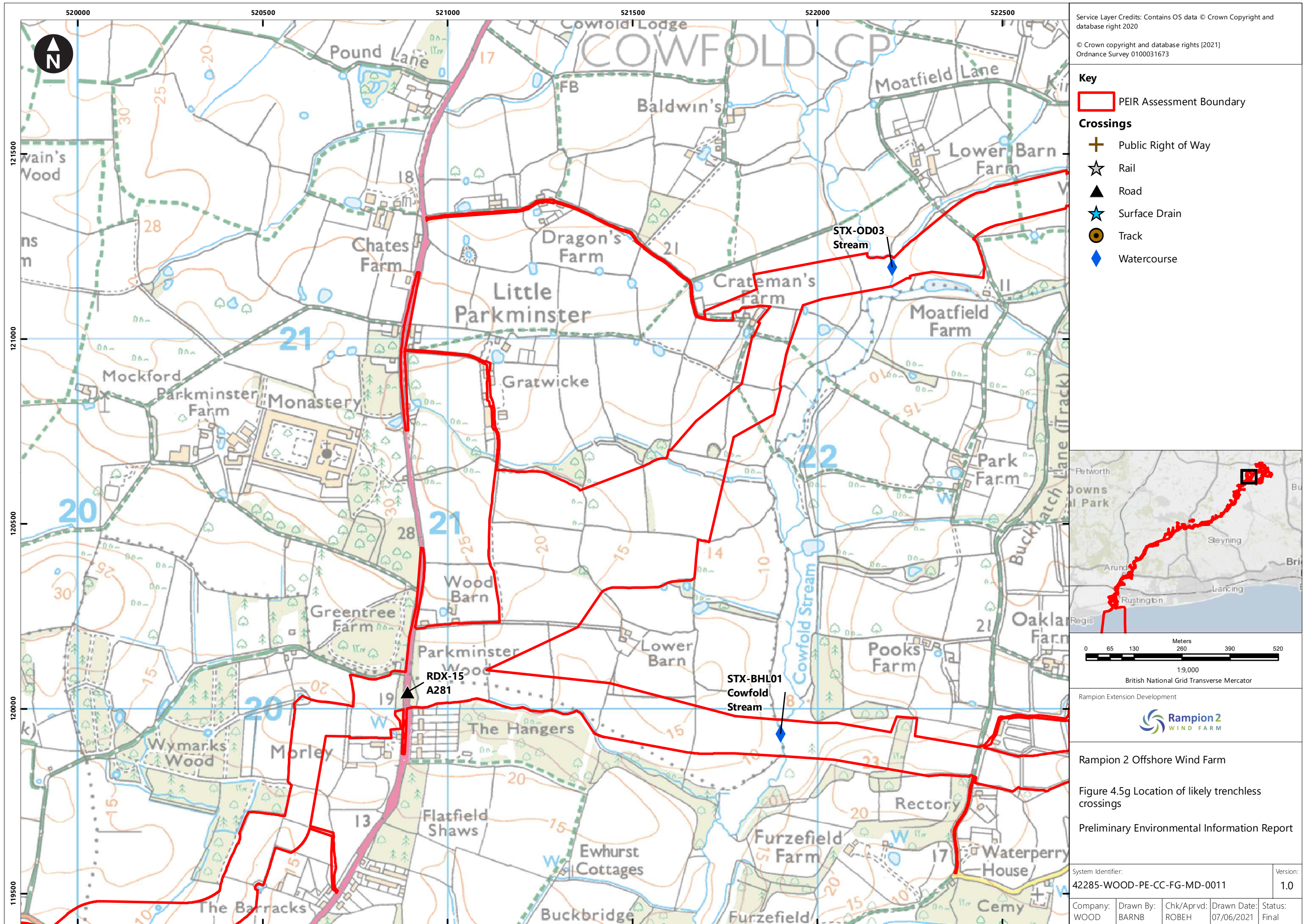

Figure 4.5f Location of likely trenchless crossings

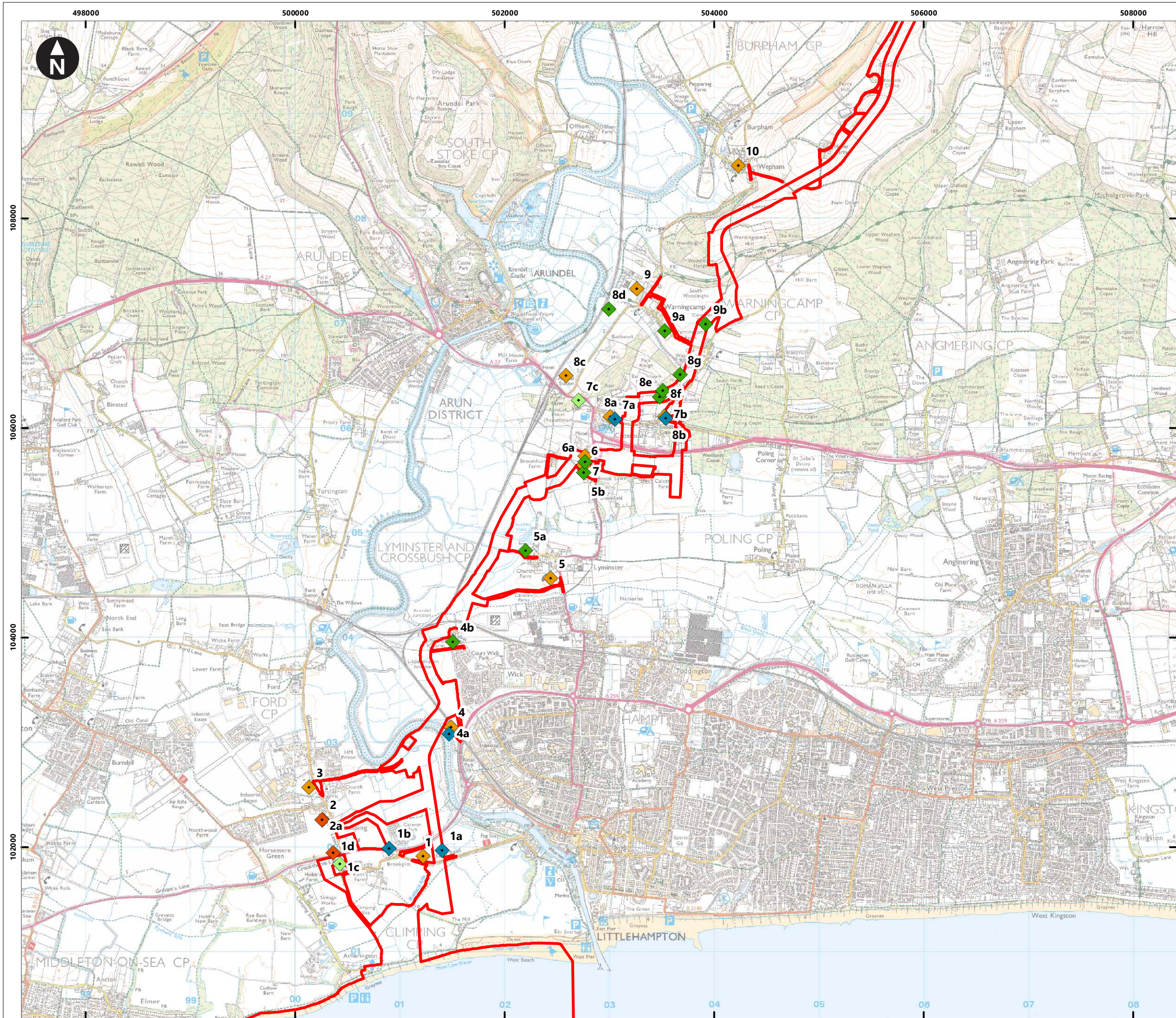

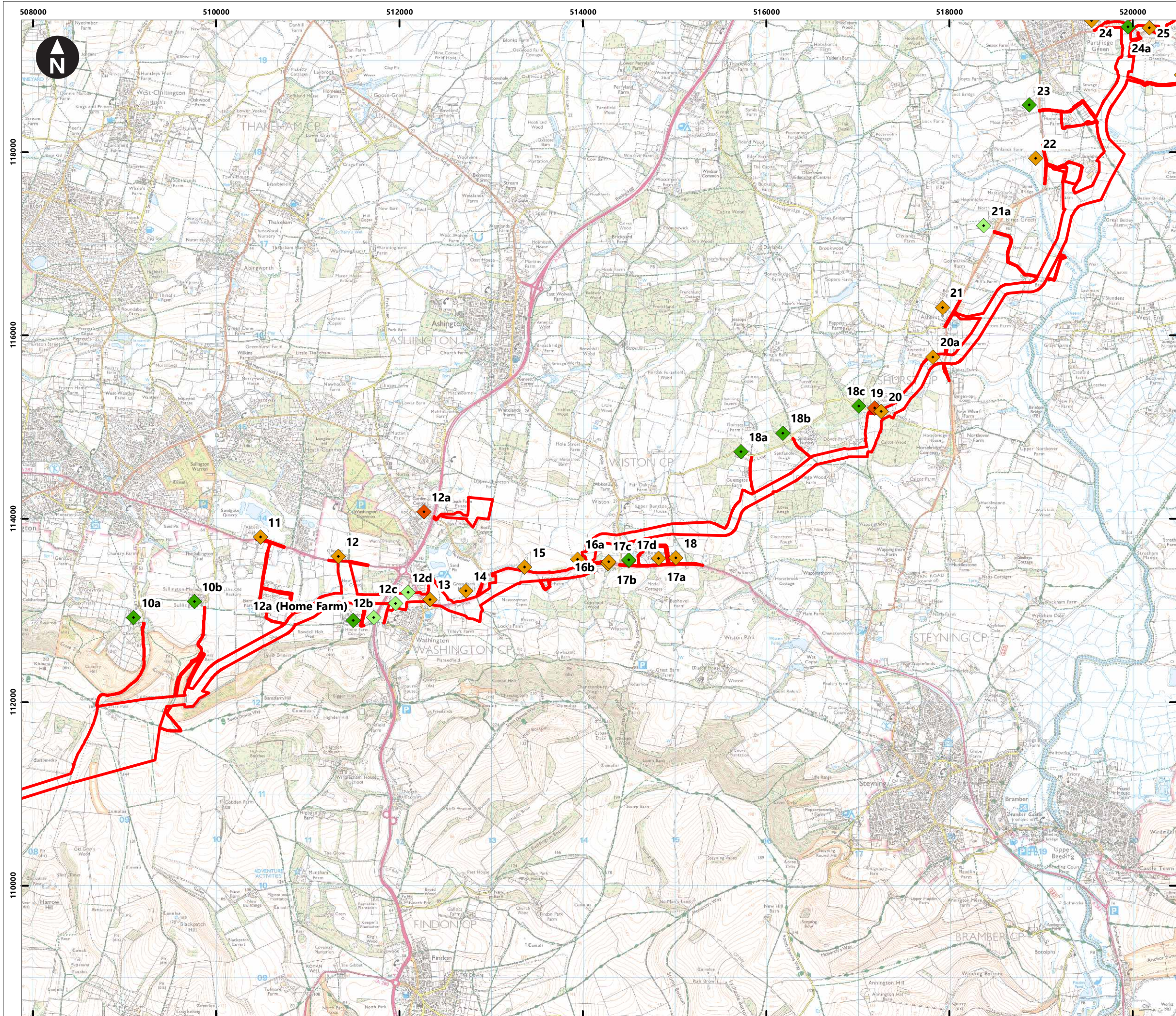

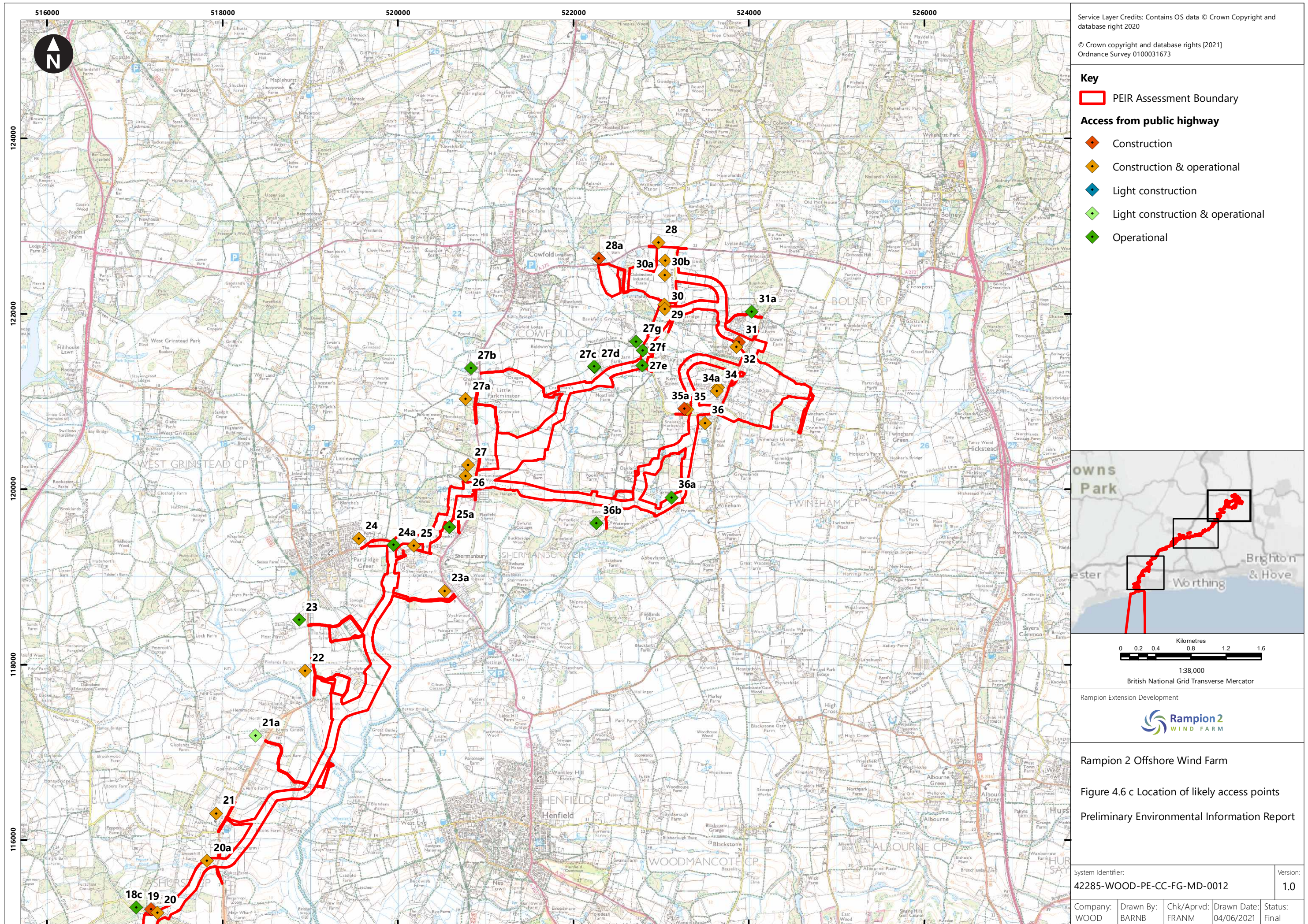
Figure 4.6 b Location of likely access points

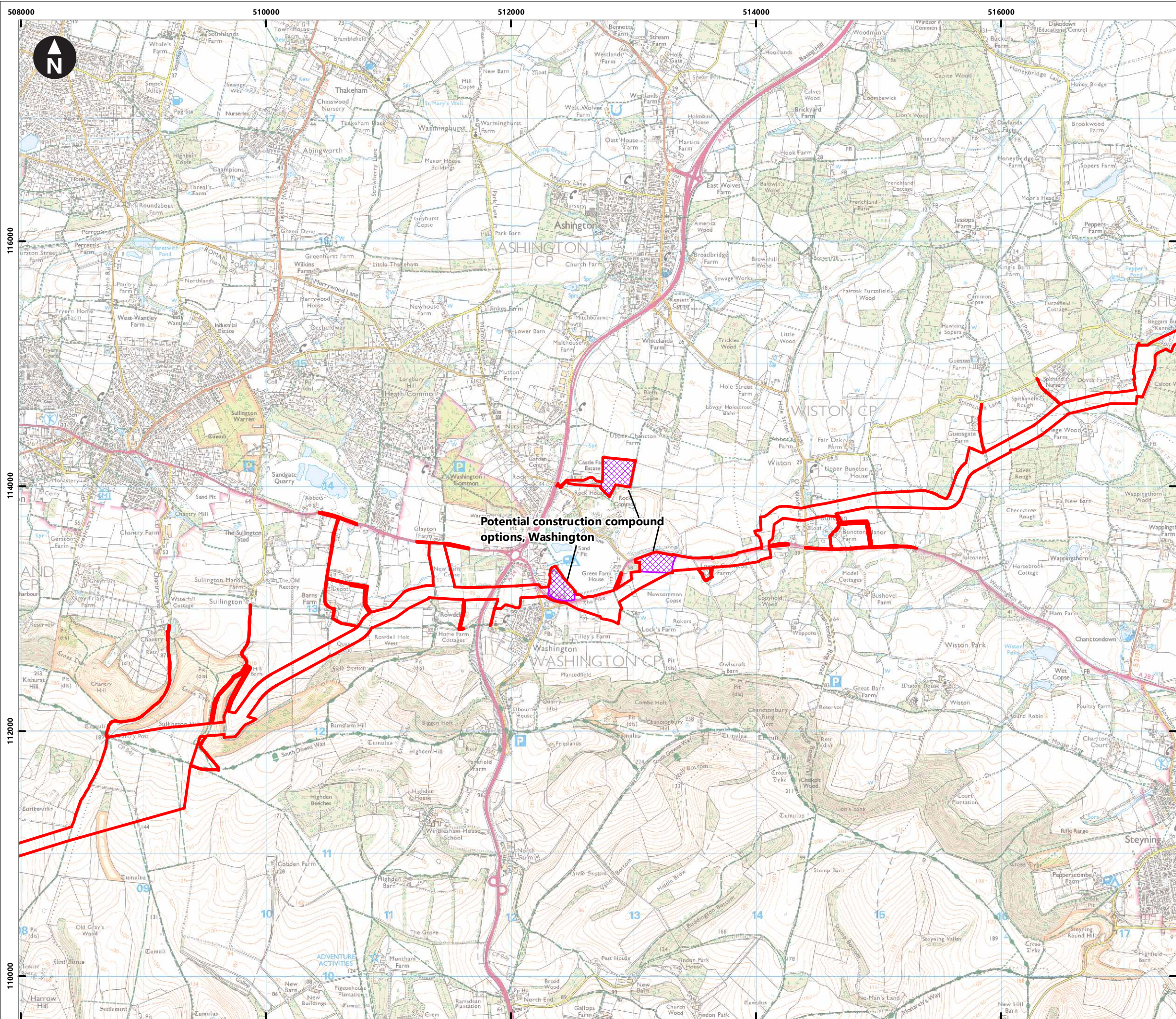

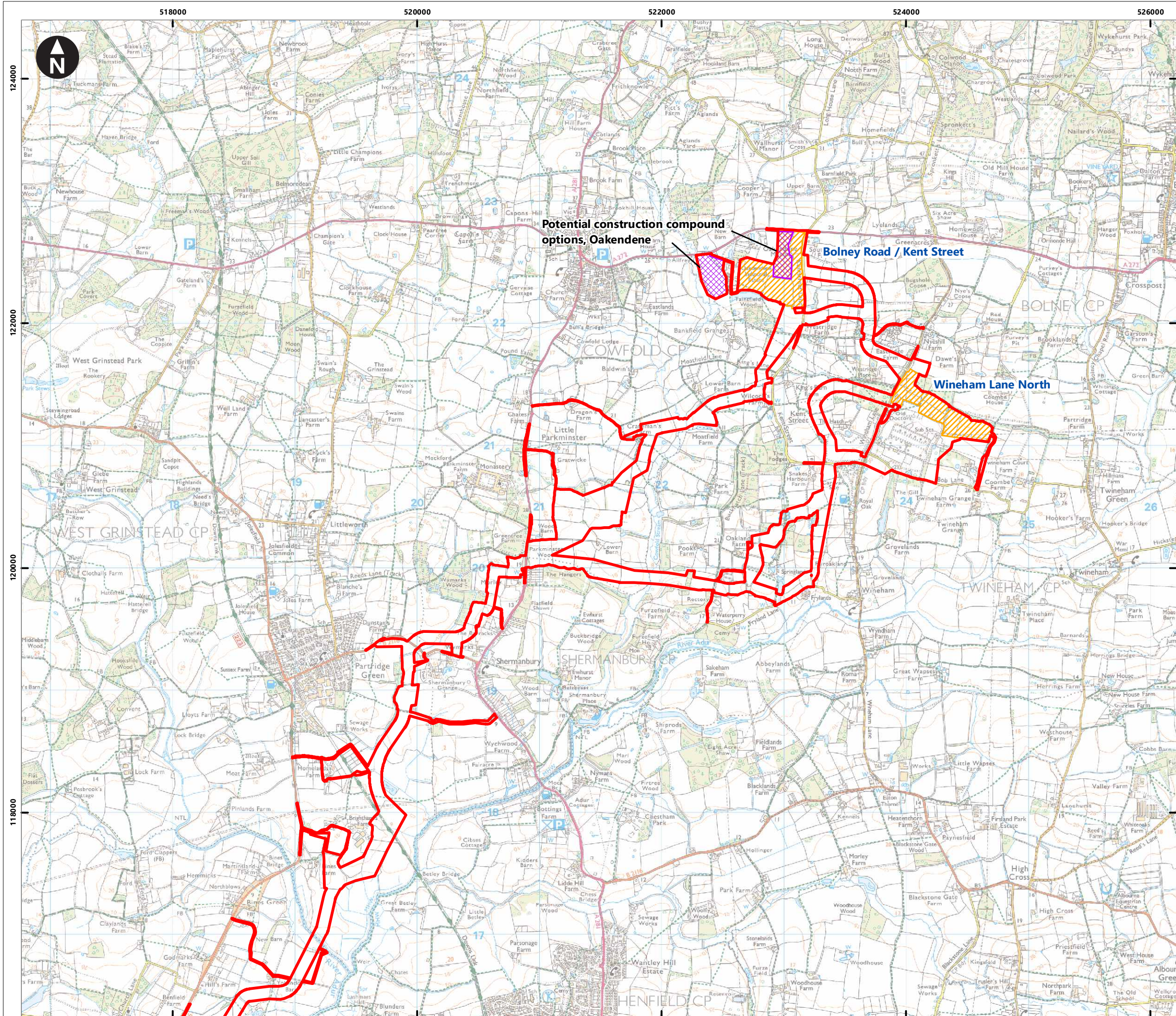

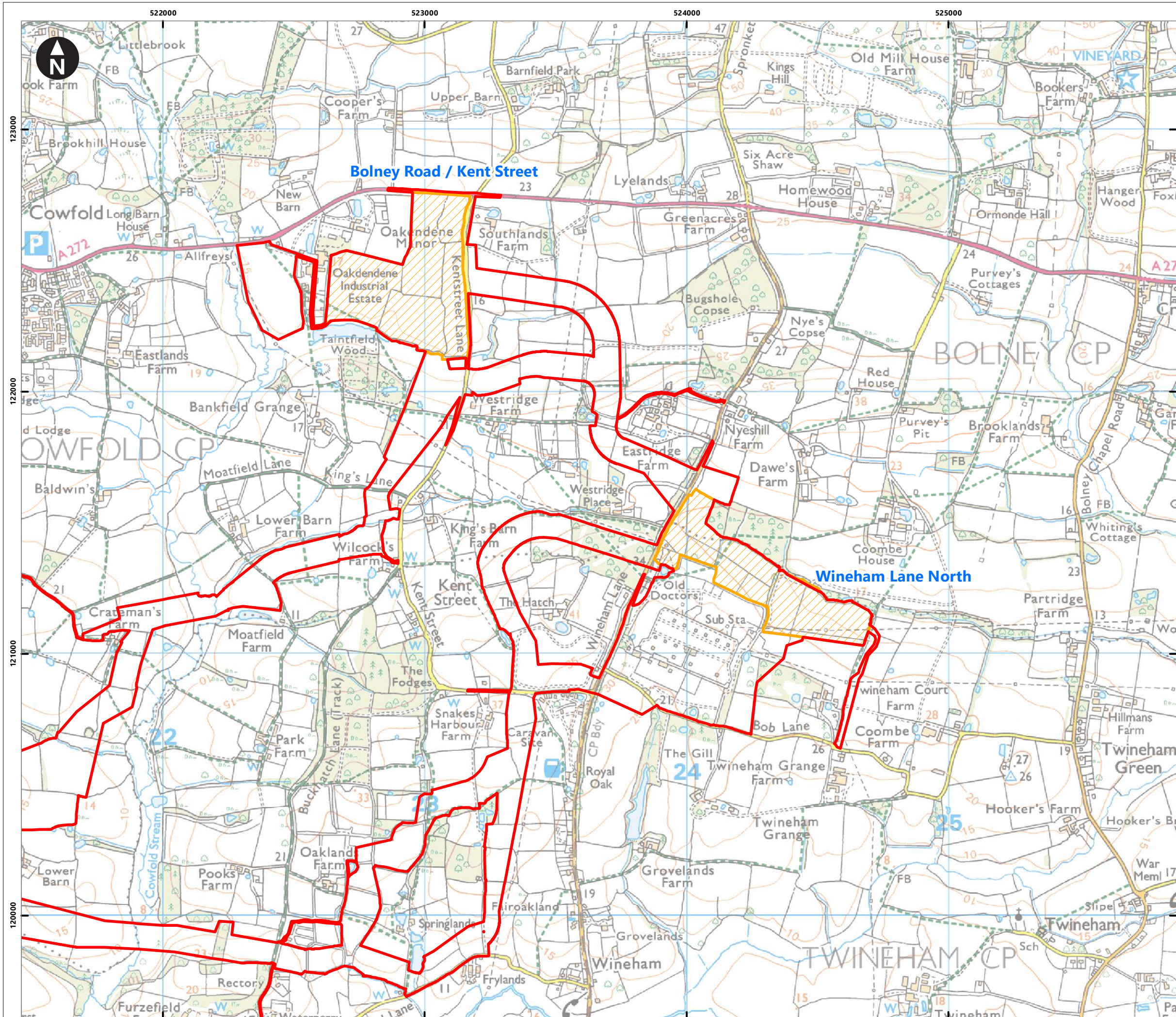
Figure 4.7C Potential construction compound locations

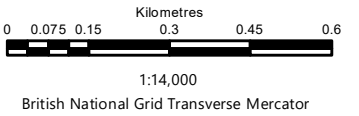
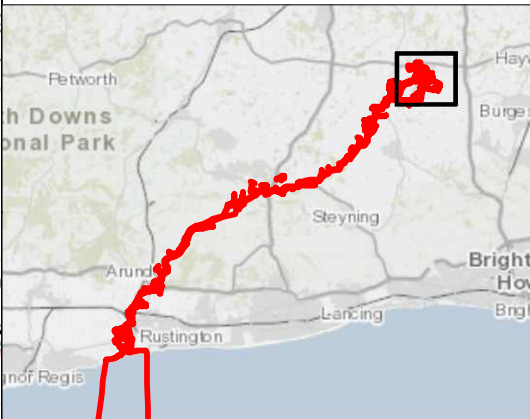
